- Crypto markets produce enormous amounts of raw data, with real-time price feeds, social sentiment, and on-chain metrics.
- Processing this data to form actionable insights is resource-intensive and out of reach for many.

3. High Costs & Lack of User-Friendly Interfaces

- Existing technical analysis tools often demand high monthly or annual fees.
- Their user interfaces assume a certain level of financial and technical understanding, leaving novices unsure of how to leverage these signals.

4. Missed Opportunities for Retail Investors

1. The Indexer

2. The Analyst

• Applies technical analysis to the indexed data.

- Uses classical indicators (e.g., RSI, MACD, Bollinger Bands) alongside LLM-driven pattern recognition.
- Generates signals—such as potential breakout alerts or overbought/oversold notifications.

3. The Communicator

- Serves as the user-facing interface.
- Adapts its communication strategy and depth based on the user's background or preference.
- Delivers insights via social media, Telegram, or purpose-built terminals.

2.3 Agent Trading and Goal Execution

In the near future, point42 will evolve to actively manage its own portfolio. By integrating standardized best practices in portfolio management, the agent will source opportunities, assess risks, and execute trades that align with predefined financial goals.
